

# General Frequently Asked Questions

## Who is EviCore?

Part of Evernorth Health Services, EviCore is a medical benefits management company that provides utilization management and prior authorization services for numerous health plans.

## Who needs to request prior authorization through EviCore?

All physicians who request/order services delegated to EviCore by our health plan clients are required to obtain prior authorization before rendering services.

## How do I request prior authorization through EviCore?

Providers and/or staff can request prior authorization in one of the following ways:

- + **Online Portal:** The EviCore portal is the quickest, most efficient way to request prior authorization. Providers can request authorization by logging in to the portal at [EviCore.com/provider](https://EviCore.com/provider).
- + **Call Center:** EviCore's call center is open from 7 a.m. to 7 p.m. local time. Providers and/or staff can request authorizations and make revisions to existing cases by calling the dedicated number for the specific health plan. Health plan-specific provider phone numbers and resources can be found at [EviCore.com/resources](https://EviCore.com/resources).

## What are the benefits of using the EviCore portal?

Our portal provides 24/7 access to submit cases or check on the status of your request.

Additional benefits include:

- + **Speed** – Requests submitted online require half the time (or less) than those submitted by phone. Online cases can often be processed immediately.
- + **Efficiency** – Medical documentation can be attached to the case upon initial submission, reducing follow-up calls and the need for consultations.
- + **Real-Time Access** – Portal users are able to see the real-time status of a request.
- + **Member History** – Portal users are able to see both existing and previous requests for a member.
- + **Clinical Consultation** – Portal users have access to self-service peer-to-peer scheduling

## Whom can I contact if I have feedback on EviCore guidelines?

## How do I check an existing prior authorization request for a member?

Our portal provides 24/7 access to check the status of existing authorizations. To check the status of your authorization request, simply log in to the portal at [EviCore.com/provider](https://EviCore.com/provider).

## What is the most effective way to get authorization for urgent requests?

Urgent requests are defined as a condition that is a risk to the patient's life, ability to regain maximum function, and/or the patient is experiencing severe pain that requires a medically urgent procedure. Urgent requests may be initiated on our portal at [EviCore.com/provider](https://EviCore.com/provider) or by calling our contact center using the dedicated phone number for that specific health plan. Urgent requests will be processed within 24 hours from the receipt of complete clinical information.

NOTE: Please select URGENT only for cases that are truly clinically urgent and not simply for a quicker review. Also, please note that any request selected as urgent that does not meet guidelines to be considered urgent may be reassigned as a routine case.

## How do I check the eligibility and benefits of a member?

Member eligibility and benefits can be verified on the health plan website before requesting prior authorization through EviCore. The EviCore portal will reflect member eligibility and authorization requirements based on information received from each health plan.

## What information is required when requesting prior authorization?

When requesting prior authorization, please ensure the following required information is readily available:

### Member

- + First and Last Name
- + Date of Birth
- + Member ID

### Clinical Information (varies based on program/modality)

- + Requested Procedure Code (CPT Code) or Treatment Plan
- + Signs and symptoms
- + Imaging/X-ray reports
- + Results of relevant test(s)
- + Working diagnosis
- + Patient history, including previous therapy

### Ordering Provider

- + First and Last Name
- + National Provider Identification (NPI) Number
- + Tax Identification Number (TIN)
- + Phone, Fax, Email Address

### Rendering (Performing) Provider

- + Facility Name
- + National Provider Identification (NPI) Number
- + Tax Identification Number (TIN)
- + Street Address

NOTE: EviCore suggests utilizing the clinical worksheets at [EviCore.com/provider/online-forms](https://EviCore.com/provider/online-forms) when requesting authorization for services. Additionally, a Required Medical Information checklist is available via the portal as a guide during case submission.

## Where can I access EviCore's clinical guidelines?

EviCore's clinical guidelines are available online 24/7 at [EviCore.com/provider/clinical-guidelines](https://EviCore.com/provider/clinical-guidelines).

## What are my options if I receive a denial and disagree with it?

The referring and rendering provider will receive a denial letter that contains the reason for denial as well as reconsideration and appeal rights processes. This determination letter is the best source to assess your options once a request is denied.

NOTE: The referring provider can go to the Authorization Lookup tab on the EviCore portal to pursue post-decision options such as a Reconsideration, Clinical Consultation (Peer-to-Peer), and/or Appeal (options vary by health plan). An appeal is the final option if a case remains denied. Medicare cases are eligible for a pre-decision consultation in the effort to prevent a denial. Once denied, a consultation is permitted post-decision, but it is for educational purposes only and will not change the case status.

## Does EviCore review cases retrospectively if no authorization was obtained?

Many health plans and/or programs allow retrospective requests to be submitted within a specific timeframe following the date of service. Please visit the health plan-specific site at [EviCore.com/resources](https://www.evicore.com/resources) for details. If a retrospective request is allowed, please have all clinical information relevant to your request available when you contact EviCore.

## How do I make a revision to an existing authorization request?

The requesting provider or member should contact EviCore to report any change to the authorization, whether the procedure has been performed or not. Any change to CPT codes or facility can be submitted via the portal. It is important to update EviCore of any changes to the authorization for claims to be correctly processed.

# Home Health Network Frequently Asked Questions

## What is the process to submit a prior authorization request?

**Durable Medical Equipment (DME) and Home Health Care (HHC):** The EviCore portal is available 24/7 and is the quickest way to initiate a prior authorization request and check case status for DME and HHC services. Providers can access the EviCore provider portal by visiting the appropriate website for the health plan at [EviCore.com](https://EviCore.com).

The EviCore portal also allows you to view all recently submitted cases, upload clinical, check member eligibility, and add multiple procedure codes when submitting a request. Any questions regarding the portal should be directed to Web Support by calling 800-646-0418 (option 2) or via email at [portal.support@EviCore.com](mailto:portal.support@EviCore.com).

Authorization requests may also be initiated via phone or fax. Dedicated call center and fax numbers for each health plan will be located on the specific health plan's resource page at [EviCore.com/resources](https://EviCore.com/resources).

**Home Infusion Therapy (HIT):** Each health plan will specify the method of prior authorization for HIT requests. EviCore will provide training sessions to educate providers on the process.

**Cigna Commercial Customers:** Home Infusion Therapy requests should be submitted directly to Cigna. Providers may call the number on the back of the customer's ID card and ask for a pre-certification intake representative to initiate an HIT request. Cigna prior authorization fax forms are located on the Cigna website at [CignaforHCP.com](https://CignaforHCP.com) > Get questions answered: Resource > Forms Center.

## What is the process for Credentialing and Re-Credentialing?

All contracted facilities are subject to the EviCore Network Standards applicable to the services they provide and the credentialing and re-credentialing process delegated to EviCore. Initially and every 36 months thereafter, Home Health (HH) Agencies, Home Infusion Therapy (HIT) Agencies, and DME suppliers must complete the EviCore Facilities Credentialing Application.
