

Addendum to the v2.0.2025 Vascular Intervention Guidelines

This addendum serves as notice to revised content within EviCore's Peripheral Vascular and Cerebrovascular Intervention Guidelines as a result of the 2026 AMA CPT® code updates. The v2.0.2026 guidelines are revised to include these code updates effective August 4, 2026. This crosswalk addresses where criteria for the CPT® codes replaced as of January 1, 2026 can be accessed in the current posted guideline.
