

2026 CPT Addendum to Cardiology & Radiology Imaging Guidelines

This addendum serves as notice to revised content within EviCore's Cardiology and Radiology Imaging Guidelines as a result of the 2026 AMA CPT® code updates. The v2.0.2026 guidelines are revised to include these code updates effective August 4, 2026. This crosswalk addresses where criteria for the CPT codes replaced as of January 1, 2026 can be accessed in the current posted guideline.
