Expanded Partnership with eviCore

Healthfirst is pleased to announce an expansion of our partnership with eviCore healthcare (eviCore). Beginning **Feb. 21, 2023**, this expansion includes the management of prior authorization for medical oncology services requested for our members enrolled in the following plans: Child Health Plus, Essential Plan, Leaf Plan, Leaf Premier Plan, Medicare Advantage plans, Medicaid, Personal Wellness Plan, Pro EPO, and Pro Plus EPO.* eviCore provides real-time clinical decision support by delivering evidence-based National Comprehensive Cancer Network® (NCCN) treatment recommendations, including supportive therapies for all cancer types.

eviCore will lead orientation sessions designed to assist you and your staff with the new Utilization Management programs. During these sessions, we will discuss in detail the prior authorization requirements for the program and how to navigate the eviCore website at **evicore.com**. Time and participation permitting, a question-answer session will follow the training session.

1. Go to eviCore.webex.com
2. Click on the menu bar on the far left of the page and select “Webex Training”
3. Under Live Sessions, click the “Upcoming” tab, then enter and search for Healthfirst Provider Orientation Medical Oncology Program
4. Click “Register” next to the session with the date and time you wish to attend
5. Complete the registration information

Effective **Feb. 21, 2023**, Healthfirst will require prior authorization for more than 200 Medical Oncology Program drugs.
