



Portal change for Cigna Healthcare home health, durable medical equipment and sleep precertification

Effective December 18, 2025, EviCore by Evernorth® (EviCore) will be transitioning Cigna Healthcare programs for home health services, durable medical equipment (DME) and sleep services to a different platform/portal. Beginning December 18, 2025, EviCore portal users will no longer request these services on eP360; EviCore portal users will need to log in to EviCore.com to make requests for these services.

Two important notes:

- 1. No changes will be made to the program requirements on December 18, 2025. This is only a platform/portal change.
- 2. Sleep requests made on eP360 prior to December 18, 2025, and that remain pending at the time of transition, will continue to be managed on eP360 until the case is finalized. Once finalized, the case will be available on EviCore.com to view or update, if needed. All finalized sleep, as well as all DME and home health, cases will migrate to the EviCore.com portal on December 18, 2025.

Starting in December 2025, EviCore will begin holding online orientation sessions to help provider staff understand how to create an account (log in) and use the portal on EviCore.com.
